### **CONSULTING FORESTERS' AFFIDAVIT**

To assist the public, Registered Foresters who sign the affidavit stating that they are a CONSULTING FORESTER based upon the following definition and standard will have their names identified by a tree symbol icon on the website:

A Consulting Forester is a Registered Forester whose principal business activity is forestry consulting work for the general public on a fee or contractual basis with no economic interest or participation in a timber purchasing or procurement entity. A Consulting Forester represents the best interest of a client and does not purchase timber or have any economic interest in logging activities as a part of his/her business.

The penalty for fraudulently using this symbol to portray oneself as a Consulting Forester will be a \$500.00 fine for the first offense and shall double with each additional offense.

**I CERTIFY that 100% of my working time is spent performing professional forestry services on a fee basis to the general public, that I offer services to the public rather than a single full-time employer, and that my primary business is consulting forestry.**
